Pastoral Service – Full-time: (<i>Manual 522</i>)	Ordained Deacon, Ordained Elder, or District Licensed Minister Various levels of pastoral service with a church; and Works 30 or more hours a week and earns at least 51% of his or her income from the church
Pastoral Service – Part-time: (<i>Manual 522</i>)	Ordained Deacon, Ordained Elder, or District Licensed Minister Various levels of pastoral service with a church; and Works less than 30 hours a week and earns less than 51% of his or her income from the church
General Church Assignment: (<i>Manual 505</i>)	Ordained Deacon, Ordained Elder, or District Licensed Minister Elected or employed by General Board to serve at the General Church level; Equal to or greater than 30 hours per week as primary assignment
Special Service: (<i>Manual 526-526.1, 536.11</i>)	Ordained Deacon, Ordained Elder, or District Licensed Minister Must be approved annually by district superintendent, District Advisory Board, and Board of General Superintendents. In active service not otherwise provided for; Ministerial capacity as an officer in a non-Nazarene church-related organization; Serving a religious educational institution, evangelistic or missionary organization not related to the Church of the Nazarene
Chaplain: (<i>Manual 506</i>)	Ordained Deacon or Ordained Elder Must be approved by district superintendent Career Military-must be approved by the Chaplaincy Advisory Council and the Board of General Superintendents Cannot use code if retired status has been granted by a district assembly
District Assignment: (<i>Manual 505</i>)	Ordained Deacon, Ordained Elder, or District Licensed Minister Elected or employed by district as their <i>primary</i> assignment

District Interim Assignment: (<i>Manual 524</i>)	Ordained Elder Recommended by district superintendent and District Advisory Board; Approved by district assembly Serves as called upon by district superintendent and local church board
Unassigned:	Ordained Deacon, Ordained Elder, or District Licensed Minister Status code used to indicate that the minister is <u>not</u> currently in an active assignment
Missionary: (<i>Manual 512</i>)	Ordained Deacon, Ordained Elder, District Licensed Minister, or Layperson If commissioned, person is appointed by the General Board, upon recommendation by the Global Mission Committee Code may also apply to persons under contract with Extreme Nazarene, Mission Corp, Tentmakers, etc.
Education: (<i>Manual 508</i>)	Ordained Deacon, Ordained Elder, or District Licensed Minister Serves as administrative staff or faculty at a Nazarene Educational Institution (i.e., college, seminary, university)
Student:	Ordained Deacon, Ordained Elder, or District Licensed Minister Code that is allowed to indicate that an individual is enrolled in a validated course of study and/or is actively enrolled with an educational institution
Christian Education Minister: (<i>Manual 510-510.1</i>)	Ordained Deacon or District Licensed Minister (deacon track) Employed by a local church school
